

- Promotion of inter-professional teamwork, e.g. in CPD
- TU "take" on scope of practice, skills mix, task shifts
- Support for ECDC survey on AMR/ABR + DG SANTE European Coalition for Vaccination
- Elaboration of Common Training Frameworks


